

Circular Letter 0048/2024

To: The Managerial Authorities in recognised Primary and Post Primary schools in the Free Education Scheme, other than Community National Schools and ETB Post Primary Schools

Revision of Salaries for School Secretaries Previously Funded Under Ancillary Grant Funding

Application of pay adjustments due on 1 June 2024

- The Minister for Education wishes to inform managerial authorities and School Secretaries of revised rates of salary of school secretaries previously funded under ancillary grant funding.
- 2. This circular sets out the new scale following agreed alignment with national pay increases. The increases only directly apply to secretaries who have moved to the new terms and conditions offered under the agreement of February 2022.
- 3. The increases will be applied and paid through the Department payroll system and schools do not need to take an action.
- 4. Pay and other conditions of secretaries who have not moved to the new terms and conditions remain a matter for the school, as employer.

Increases in Salaries

- 5. Whole-time annual basic scale salaries will be increased by 1% with effect from 1 June 2024.
- 6. Revised salary scales to affected staff are superseded by the terms of this Circular with effect from 1 June 2024 are set out in Appendix 1. The corresponding hourly rates for School Secretaries are included so as to provide further clarity for secretaries.
- 7. Hourly casual rates for School Secretaries are attached at Appendix 2.
- 8. All salary scales and hourly casual rates payable to School Secretaries set out in previous Circulars are superseded by the terms of this Circular with effect from 1 June 2024.
- 9. Overpayments will be dealt with in accordance with the procedures set out in Circulars 0084/2015.
